Mayor Luz thanked the Finance Director for her comments and introduced Chief Bowker, who has worked with the city since 2005. The Mayor asked Chief Bowker to describe the work environment he experiences and the leadership style of the City Manager. Chief Bowker stated he believes the work environment at the Police Department is fine, but that there is a toxic environment at the City Hall. He described the toxic environment as personal issues between a couple of individuals that trickle down to the rest of the staff, which has begun to affect his personnel. Chief Bowker has also asked his records clerk to not go to City Hall unless she absolutely has to in order to not put her into a negative environment. Some officers have expressed their concerns about the change in attitude of staff members. He has done everything he can to shield the Police Department from anything going on at City Hall or Public Works. He noted it is not in his position to tell or ask the City Manager what leadership style he or she should have. The City Manager will run the city the way they see fit. He will, however, speak up when anything starts affecting his department, though the impact has been minimized. The Police Chief believes there is a trust issue between the staff and City Manager. Chief Bowker emphasized he has told his officers he doesn’t want to hear people talk poorly about supervisors or staff in other departments. He stated when he hears of things the City Manager has said negatively towards department heads, it is upsetting. The Finance Director has mentioned concern for her job, but the Police Chief is not in fear of losing his job. The current negativity in the city saddens him.

Bynum Voted To Require Insurance Coverage For Abortion And Contraceptives. In July 2017, Bynum voted for HB3391 which, “Requires health benefit plan coverage of specified health care services, drugs, devices, products and procedures related to reproductive health. Allows exemption for plans sold to religious employers. Requires the Oregon Health Authority (OHA) to implement a program to reimburse the costs of the services, drugs, devices, products and procedures relating to reproductive health provided to the individuals who can become pregnant and who would be eligible for medical assistance if not for certain federal requirements. Clarifies pharmacy claims reimbursement; aligns current statute to federal regulations and requires Health Evidence Review Commission to review the services provided in Section 2 and submit a report no later than November 1 of even-numbered years. Prohibits discrimination in provisions of health care coverage. Prohibits interference by public body in a consenting female's choice to terminate pregnancy. Prohibits public body's interference with health care provider terminating or assisting in termination of pregnancy of health care provider's patient, if the health care

provider is acting within the scope of the provider's license. Declares emergency, effective on passage.” The bill passed the House 33-23. [Oregon Legislature, HB 3391, [7/1/17](#)]

HB 3391 Requires Health Plans Sold In Oregon To Provide Coverage For A Suite Of Reproductive Health Care Services At No Out-Of-Pocket Cost To The Insured. “The new law requires that health plans sold in Oregon ‘must provide coverage’ for a suite of reproductive health care services at no out-of-pocket cost to the insured. Services covered include: Screenings for pregnancy, sexually-transmitted infections, breast and cervical cancers, genetic cancer risk factors and other health problems; counseling for tobacco use, STIs, breast cancer treatment and domestic violence; breastfeeding support; contraceptive drugs and devices, including insertion and counseling; voluntary sterilization and abortion.” [Oregonian, [8/30/17](#)]

Legislation Introduced By Democrat Susan Wild To Protect IVF Had Over 90 Co-Sponsors. “Today, Congresswoman Susan Wild joined members of the Democratic Women’s Caucus (DWC) to call on Congress to pass the Access to Family Building Act, which would protect in-vitro fertilization (IVF) access nationwide. That's why she took on drug companies to crack down on price gouging and cap the cost of insulin, ...

Bynum Voted For Senate Bill 1508 Which Caps Out-Of-Pocket Costs For Insulin At \$35 For A 30-Day Supply. Bynum Voted For Senate Bill 1508 which, “prohibits the Health Evidence Review Commission (HERC)

from relying upon any quality of life (QALY) measure in determining coverage of services by the Oregon Health Plan (OHP). It caps out-of-pocket costs for insulin at \$35 for a 30-day supply and \$105 for a 90-day supply.” The bill passed both chambers and was signed into law. [Oregon Legislature, HB 1508, [3/25/24](#)]

... and expanded access to affordable housing in Oregon, and sponsored Oregon's child tax credit.

Oregon SB 5505 Funded The LIFT Program That Created New Affordable Housing Units. “The budget bills fund an increase in supply of safe, stable, and affordable housing, as well as permanent supportive housing across Oregon. S.B. 5505 allocates \$410 million in Article XI-Q General Obligation bonds over FY22 and FY23 for the Local Innovation and Fast Track (LIFT) program and permanent supportive housing. The LIFT program creates many new affordable housing units – both rental and homeownership – to serve low-income Oregonians and historically underserved communities.” [National Low Income Housing Coalition, [7/12/21](#)]

Oregon HB 4007 Would Increase The Document Recording Fee To Generate Revenue For Affordable Housing. “Everyone in Oregon should be able to access opportunity, which starts with having a safe, stable, and affordable place to call home. In rural and urban counties across the state, far too many of our neighbors and community members are struggling to make ends meet and must choose between paying rent and paying for food, medicine, and transportation for their families. More than 22,500 school children experienced homelessness at some point during the last school year. Our state must invest more in housing opportunity—and we can expand our investment through an increase to the document recording fee. The document recording fee is a fee paid when recording real property documents, and provides dedicated, ongoing funding for affordable housing. Since its inception in 2009, the fee has generated \$91 million in resources to help more Oregonians afford a safe, stable place to call home. In 2018, the Oregon Housing Alliance is asking the Legislature to pass HB 4007, which would expand the document recording fee to \$75 to help address this housing crisis. The document recording fee creates critical resources for investment in housing opportunity to benefit Oregonians statewide, and a \$75 fee would generate a total of \$105 million per biennium. Funds from the document recording fee address the entire spectrum of housing needs: preventing and ending homelessness, building new affordable housing, and creating affordable homeownership opportunities. One out of every four dollars from the document recording fee is dedicated to serving veterans.” [Oregon Housing Alliance, accessed [4/2/24](#)]

In 2023, Bynum Sponsored And Voted In Favor Of A Bill To Create The “Oregon Kid’s Credit”, A Refundable Tax Credit Available To Oregon Families With Dependents Under Six Years Of Age. Bynum sponsored and voted for HB 3235 which, “Creates refundable income tax credit for resident with qualifying dependent children under age six of \$1,200 per dependent. Limits claims to five dependents per tax return. Limits eligibility to taxpayers with federal adjusted gross income under \$50,000 for joint return or \$30,000 otherwise. Prescribes formula for reducing credit amount for taxpayers with adjusted gross income over \$40,000 for joint return or \$20,000 otherwise. Directs Department of Revenue to annually adjust credit amounts and phaseout thresholds for inflation. Allows amount of credit to be prorated according to changes in taxpayer status or taxable year. Provides that credit is not subject to judicial execution of judgment or garnishment. Applies to tax years between 2024 and 2030. Takes effect on 91st day following adjournment sine die.” The bill passed 51-1 and was signed into law. [Oregon Legislature, HB 3235, [6/22/23](#)]
